### 1 Introduction

### 1.1 Scope of this Manual

In accordance with ANSI B56.1 (7.2.1) and B56.5, this manual has been developed to guide the user in the safe operation of this FoxBot Autonomous Forklift (FoxBot). The manual is divided into several logically-ordered sections for ease of use. The scope of material included in this manual is limited to account only for specific operations and recommended procedures considered to be routine. The intent of this manual is to guide the operators and service technicians in the basic setup, operation, and maintenance of this equipment. This manual is NOT provided as a reference on mechanics, electronics, or hydraulics.

### 1.2 Operational Limitations

This manual is provided as a guide for most normal operations and the care and proper operating specifications of the equipment. Due to the varying environmental conditions and the nature of equipment operation, it is not possible to account for every possible unknown variable. Therefore, it is requested that when situations arise outside of the scope of this publication, operators should contact Fox Robotics directly for further assistance. Fox Robotics reserves the right to make design changes without incurring any obligation for the equipment or manual previously delivered.

### 1.3 How to Use this Manual

To the extent it is practical, this manual will cover all of the additions and components added to the base model forklift. For specifics on the base model forklift and other system components, see the <u>Appendix</u> for the specific <u>OEM Manual</u>.

# 2 Unit Description

The FoxBot Autonomous Forklift is an autonomous, self-driving forklift engineered and designed to unload semi-truck box trailers with minimal or limited human interaction.

It can be operated in one (1) of two (2) modes: Autonomous or Manual.

In Autonomous mode (without an onboard operator) the FoxBot requires minimal setup and then can be set free to do its work. In Manual mode, the FoxBot can be driven by an onboard operator that controls the FoxBot using local controls, much like a standard forklift.

The FoxBot Cabin (Cab) area can accommodate a single user, in the vertical (standing up) position. All controls are positioned well within the operator's line of sight and are easily manipulated/functioned.

The FoxBot is battery-powered and will hold a charge for approximately eight (8) hours, under general workload. Battery life may vary substantially with the level of use.

In Autonomous mode, the FoxBot can be controlled and monitored remotely, if necessary. There are five (5) Emergency Stop (E-Stop) buttons located around the FoxBot in case an emergency situation arises. Additionally, there are other sensors that constantly monitor real-time operating conditions of the FoxBot, such as sensor connection, battery power, and loss of power.




Figure 2 - Complete FoxBot Assembly (Side Views)




Figure 3 – Complete FoxBot Assembly (Front & Top Views)

- 1) The "Mode Selector" switch puts the FoxBot in either Autonomous or Manual mode.
- 2) The "Home" Button brings everything into the start/run position for Autonomous mode.
- 3) The "Reset" Button clears all previous states and readies the FoxBot for new input.
- 4) The "Safety Bypass Switch" disables autonomous mode and allows the robot to drive at severely reduced speeds, even if E-Stop switches have been damaged.

# 3 Shipping, Receiving, and Setup

### 3.1 Shipping

If shipping the FoxBot becomes necessary, it should be prepared, loaded, and secured according to the directions below.

### 3.1.1 Prepare the Robot for Transportation

- Ensure the electronic backpack cover is latched and taped closed, with all wires and cables tucked within the cover
- Perform an operational check of all mechanical capabilities
- Check the battery conditions (electrolyte levels, terminal connections, leaks, security, and charge)
- Perform a walk-around inspection, checking for any visible damage or disconnected harnesses
- Check the condition of all LiDAR sensory units
- Ensure the tablet is powered off and secured in the docking station for shipping

### 3.1.2 Load the Robot

- Safely drive the robot in reverse onto the transport vehicle. Tines should be facing away from the cab of the transport vehicle.
- Place the robot within the area of installed D-ring tie-downs.
  - E-track straps may be used to secure the robot instead of chains and binders.
- Ensure the area around the robot is free of loose or unsecured items.
- Lower tines to the floor and power off the robot.
- Remove the keys and disconnect main battery power.

### 3.1.3 Secure the Robot

- Chock wheels with wood wheel chocks, with the angled portion of the wheel chock in contact with the wheels and chassis.
  - Secure the following wheels and chassis: Front left wheel, front right wheel, steer-side chassis left of the operator cabin, steer-side chassis right of the operator cabin, left-side chassis (NOT under LiDAR fenders), and right-side chassis (NOT under LiDAR fenders)
- Secure each wheel chock with 2x T25 deck screws, angled so they make contact with the trailer floor. Do not reuse old screws.
- Securely chain or strap the mast to the floor, if possible.
- Secure the front carriage to each, D-ring, E-clip, or securing location with chain, binders, or load-rated equivalent ratchet straps.
  - Pull chain, binders, or straps in opposite directions, if possible.
  - Use 4 chains, binders, or straps at a MINIMUM (2 for the mast/side-shifter assembly and 2 inside the battery well tensioned on the chassis, NOT the battery itself).
- Install rear shipping hooks, if available, by threading into lower mounting point facing the hooks in opposite directions. Use chain and load-equivalent straps to secure to D-rings, pulling in opposite directions.

### 3.1.4 Secure the Batteries/Chargers

- Load the battery on a pallet, preferably one with battery retaining boards.
- Position the pallet near the trailer wall with available E-track spots.
- Use 2 load-rated ratchet straps to secure the long side of the battery against the trailer wall.
- If you are shipping the chargers before initial use, they will be bolted to a pallet. Ensure the cardboard cover is in place with the cabling tucked inside.
- Secure the charger with one load-rated ratchet strap against the trailer wall, in the same fashion as the batteries.

### **↑ WARNING**

ALWAYS transport the FoxBot with the "forks" facing the rear of the trailer, away from the truck cab. This is to prevent forks from being thrust into the truck cab in the event of an accident! Failure to observe this label could result in serious bodily injury or DEATH!




Figure 5 – Shipping a Single FoxBot




Figure 6 – Shipping Multiple FoxBots

### 3.2 Receiving and Inspections

- Remove all shipping/packaging material and verify that there are no signs of "in-transit" damage.
- Ensure that all "shipping only" brackets/braces are removed, as required.
- Ensure that all unit fasteners are tight and did not vibrate loose during transportation.



### NOTICE

If damage is discovered, take plenty of pictures to adequately document the damage.

### 3.3 Required Site-Service Connections



### **△ WARNING**

Electric Forklift Charging Stations can be extremely dangerous. Ensure that only qualified, well-trained operators connect and disconnect the charging station cables. Failure to observe this label could result in serious bodily injury or DEATH!



### **⚠ WARNING**

The user shall maintain batteries and changing and charging systems in accordance with ANSI/NFPA 505. Battery types and charging systems supplied or specified by the vehicle manufacturer (e.g., opportunity charging) but not referenced in ANSI/NFPA 505 shall be maintained in accordance with instructions supplied by the vehicle manufacturer. Failure to observe this label could result in serious bodily injury or DEATH!



### **↑ WARNING**

Battery types and charging systems supplied or specified by the vehicle manufacturer (e.g., opportunity charging) but not referenced in ANSI/NFPA 505 shall have safe operating and charging instructions supplied by the vehicle manufacturer. Failure to observe this label could result in serious bodily injury or DEATH!

### 3.4 Designate an Operational Area and Setup

- Ensure that the operational area is prepared to accept this equipment.
- Ensure that the operational area provides ample room to operate.
- Ensure that the operational area is well lit, per ANSI/IES RP7.
- Ensure that the operational area is level (within a ±5% grade) and free of debris, and/or unnecessary obstructions.
- Ensure that the operational area provides enough strength to support the weight of the equipment being placed upon it.
- Ensure that the FoxBot does NOT carry any hazardous loads.
- Ensure that all loads to be picked by the FoxBot fit with the confines of a standard Grocery Manufacturers Association (GMA) sized pallet (48" x 40").



### **NOTICE**

The FoxBot's primary safety and navigation sensors are positioned to sense objects 10 cm above the ground. The operational area should be kept clear of obstacles that cannot be sensed at this height, such as overhanging obstacles or holes.



### **A** CAUTION

Caution should be exercised with changed environments. Changes in weather, surface conditions, or applications may affect the vehicle stopping distance; speeds, loads, brake settings, and/or operation should be adjusted accordingly. Failure to observe this label could result in minor or moderate injury.




### **⚠ WARNING**

All operational areas of the FoxBot should be considered "hazardous zones" and precautions should be taken to avoid unnecessary safety risks. Failure to observe this label could result in serious bodily injury or DEATH!



### **↑ WARNING**

It is also important to remember that the FoxBot is a robot and as such can turn "off" its "safety" systems without explanation. The safety systems may also simply become damaged. Pay close attention to the FoxBot's operation at all times. Failure to observe this label could result in serious bodily injury or DEATH!



**NOTE:** A 15 ft clearance to adjacent obstacles is required for approach directions and 2 ft clearance is required for other directions.




Figure 8 - Typical Dock Measurements




Figure 9 – Sample "Safe Travel Zone" Markings

### 3.5 Pre-Run Setup



# **NOTICE**

The following setup instructions will only need to be done once per dock location. If multiple FoxBots will be in use at multiple dock locations, setup will have to be carried out at each location.



### **NOTICE**

If the FoxBot cannot be localized (spatially) by the app (an error note within the app will indicate this), verify the condition of the sensors. They may simply need to be cleaned.

- 1) Connect all Tablets to the same WiFi network as the FoxBot. This may be a customer-provided WiFi network or the "FoxLTE" Wifi network.
- 2) Turn "ON" the onboard tablet and launch the FoxLift App.

- 3) Select your FoxBot (by name, if applicable) and "Start Run".
- 4) Press the "Green" Button (on the Computer Enclosure) to "Home" the FoxBot.
- 5) Point the FoxBot at the "Right" Dock Tag. A "tag" is a small pole mounted sign consisting of a QR code placard sitting atop a small 4-foot pole.

If, at any time, the operator or nearby personnel feel there is something wrong or an unsafe condition exists, any of the 5 E-Stops may be depressed (activated) to immediately stop all FoxBot function(s).




Figure 12 – Setup Step 1




Figure 13 – Setup Step 2




Figure 14 – Setup Step 3

# 4 Pre-operational Inspections and Testing



### NOTICE

Visual inspections should occur at the beginning of each shift and/or as issues arise during use. If any of these instructions are unclear, call Fox Robotics Engineering for resolution.

Prior to inspection(s) ensure that the FoxBot is resting in a safe, powered-down state. Failure to observe this label could result in serious bodily injury or DEATH!

Prior to operating the FoxBot, the "Daily Function Test" needs to be performed. Refer to the Daily Function Test Log in the Appendix (8.2 Inspection, Tests & Maintenance Logs). If necessary, Refer to sections (2.5 Unit Components or 7 Drawings and Bills of Materials) for locations of inspection items.

### 5.1 Stack Light Descriptions



Figure 15 - Typical Stack Light Color Codes

**GREEN** - Communicates the operational mode.

SOLID - The FoxBot is "ON" and in "Manual" mode.

BLINKING - THE FoxBot is "ON" and in "Autonomous" mode.

**YELLOW** - Communicates a hazardous condition.

SOLID - The FoxBot is in "Autonomous" mode but has not gone through its startup procedure.

BLINKING - A hazard is present:

- One or more safety scanners has been disabled (The FoxBot must be moving slowly)
- The FoxBot is going through its startup procedure (5 seconds of lights and sounds)
- The safety bypass switch is active

**RED** - Communicates a fault in the system that requires human intervention.

(If the red light is "ON," the FoxBot is safe to approach and will not resume moving on its own without operator intervention.)

SOLID - The red light will turn on if:

- A chassis-mounted E-Stop (5) is pressed
- An internal fault is detected by the robot that requires the FoxBot to stop for safety

BLINKING - The red light will flash if the reset button needs to be pressed to acknowledge the internal fault. The red light will extinguish when both the original event has cleared and the reset button has been pressed, at which point the FoxBot may resume motion.

**BLUE** - Provides a means for the FoxBot to ask for help from the operator.

SOLID – The FoxBot is actively requesting an intervention.

### **NOTICE**



- 1) During normal operations, one or more Stack Light(s) should always be on or blinking. During system power-on or in the presence of a severe fault, the Stack Light may not illuminate.
- 2) A red light indicates that the FoxBot will not resume without human intervention. Even when the fault conditions are clear, the FoxBot must go through a startup procedure, indicated by a yellow blinking light (which indicates a hazard), for a period of time before resuming movement in "Autonomous" mode.

### 5.2 UPS and Battery System

### 5.2.1 Theory of Operation

To facilitate keeping the autonomy system alive through **loss of power events**, such as a changing of the primary 36V battery, the FoxBot is equipped with an <u>Uninterruptible Power Supply</u> (UPS) that protects the primary autonomy computer.

This UPS can select between two energy sources:

- 1) The primary forklift battery, as described in <u>Section 2.1 (Performance Data)</u>. This battery provides power for the entire forklift during normal operation(s).
- 2) A secondary, 24V backup battery.
  - The UPS continuously monitors its own input power channel and, if it detects loss of power, will switch to the battery backup. The input power channel of the UPS is sourced from one of two locations:
- 1) If the 110V plug on the backpack is plugged in and active, then the robot is said to have **shore power.** The robot will use this channel to power the UPS. Otherwise,
- 2) The primary 36V battery is used if no **shore power** is present.

The battery backup can keep the autonomy computer alive for approximately 45 minutes on a full charge. When the backup is engaged, the system will beep slowly. Connecting the primary battery or shore power will silence this.

### 5.2.2 To Isolate Power

Remove the 110V plug into the backpack to remove shore power.

Disconnect the primary 36V battery.

Press and hold the UPS/Reset Button on the dash for 5 seconds. An audible beep should sound and the light on the switch will extinguish.



### **⚠ WARNING**

Power from the backup battery into the UPS remains present even if the UPS is disabled. Complete isolation requires removal of the backup battery. Failure to observe this label could result in serious injury or DEATH!

#### 5.2.3 To Restore Power

- 1) Press and hold the UPS/Reset Button on the dash for 5 seconds. An audible beep should sound and the light on the switch will illuminate.
- 2) Reconnect the primary 36V battery.
- 3) Ensure the backpack is closed and secured.

### **5.3 Safe Operation Parameters**

- 1) Do **NOT** approach the FoxBot unless the stack light is red (or solid green).
- 2) Do **NOT** approach the FoxBot when the stack light is blinking or there is an audible "beeping".
- 3) Do **NOT** enter the trailer while the FoxBot is active.
- 4) If you must approach a FoxBot while it is in autonomous operation, use a tablet to cancel the current operation.
- 5) If the vehicle is stuck, follow instructions on the tablet screen or if in doubt pick and place the next pallet manually.

### 5.4 FoxBot Start-Up

- 1) Ensure the FoxBot is disconnected from shore power.
- 1) Connect the primary 36V battery to the FoxBot (via Anderson, "Main Power" Plug).
- 2) Ensure the UPS is ON by inspecting the light switch on the dash..
- 3) Wait for the stack light to illuminate. This indicates that the system is booted up.
- 4) When the FoxBot first starts, it will automatically fault to prevent unintended motion. Press the reset button to clear it
- 5) The FoxBot is ready to run in either manual or autonomous mode.

### 5.5 Manual Mode

Refer to the Appendix (8.4 OEM Forklift Operation and Maintenance Manual) for specific instructions on how to operate this FoxBot in manual (rider) mode.



# **STOP**

If, at any time, the operator or nearby personnel feel there is something wrong with the FoxBot or an unsafe condition exists, any of the 5 E-Stops may be depressed (activated) to immediately stop all FoxBot function(s).



### **⚠ WARNING**

The FoxBot should be always driven at safe speeds by a qualified operator when used in "Manual" mode. Failure to observe this label could result in serious bodily injury or death.




Figure 17 – Generic Tablet Home Screen (FoxLift App)




Figure 18 - Forklift Selection Screen




Figure 19 - Start Forklift Screen




Figure 20 - Select Place Zone Screen




Figure 21 - Select Pick Zone Screen




Figure 22 - Submit Goal (Run)

### 5.7 Shutdown Procedures

- 1) From the Tablet, select "SHUTDOWN".
- 2) From the Computer Enclosure, turn the selector switch to the "Manual" mode.
- 3) From the Computer Enclosure, press the "Reset" button.
- 4) Manually drive the FoxBot to the designated "charging" station/location.
- 5) Lower the forks to the floor.
- 6) Turn off FoxBot using the key switch (turn the key CCW).
- 7) Plug in 110v shore power (if present) for the computer.
- 8) Charge the FoxBot Battery per the OEM charger instructions.
- 9) Charge the e-stop, tablet, and any other accessories.

### Rescue (Tow) Procedures

If the FoxBot loses power and/or communications while inside a box trailer, it may become necessary to initiate "Rescue Tow" procedures. Use caution when executing a rescue towing procedure. When possible, minimize the distance that the FoxBot is towed, to reduce wear on tires and brakes.

Attach one end of an appropriately rated tow strap to the designated connection point on the FoxBot.

- 10) Attach the other end of the tow strap to a vehicle, capable of "pulling/towing" the FoxBot.
- 11) Carefully pull the FoxBot to the desired location.




Figure 23 – Typical Rescue Tow Set-up

### 5.8 Long-Term Deactivation

It may be necessary to remove this equipment from service for extended periods of time. It is highly recommended to perform some basic preservation tasks to maximize the storage life of the equipment and minimize the expense of re-activating the equipment after prolonged storage. Aside from specific requirements, regular visual inspections should occur to ensure that the unit is protected from the harsh elements during storage.

Prior to storage, this unit should be washed with water and mild detergent and dried. This unit should be stored in a climate controlled, dry environment.

### 5.8.1 Outside Storage (exposed to the elements)

This unit is NOT rated for outside storage.

### 5.8.2 Inside Storage (protected from the elements)

All load(s) must be removed from the forks and the forks lowered to rest on the ground during long-term storage. Disconnect the main 36V battery by unplugging. (Press and hold the UPS/Reset Button on the dash for 5 seconds. An audible beep should sound and the light on the switch will extinguish.)

#### **FOREWORD**

The Occupational Safety and Health Administration (OSHA) prohibits employees under the age of 18 years old from operating forklift trucks, and is now mandating operator training for all forklift truck operators.

SAFE and EFFICIENT OPERATION of a forklift truck depends to a great extent on the skill and alertness of the operator. To develop the skill, the operator should read this manual to understand the following points.

- (1) Working capabilities and limitations of the forklift truck.
- (2) Make-up of the forklift truck.
- (3) Safe driving and load handling procedures.

It is the employer's responsibility to make sure the operator can see, hear and has the physical and mental ability to operate the forklift truck safely.

It is also important that a qualified person experienced in forklift truck operation should guide new operators through several driving and load handling operations before they attempt to operate the forklift truck on their own.

#### Note:

- This manual contains information necessary for the operation and "Do-it-yourself" maintenance of standard forklift trucks.
- Optional equipment is sometimes installed; it can change some operating characteristics described in this manual. Before operating such a forklift truck, make sure the necessary instructions are available and understood.
- Forklift truck operator training is provided through your authorized dealer. They will be glad to help you and answer any questions you may have about operating your new forklift truck. Forklift trucks are NOT intended for use on public roads.
- If you resell a forklift truck, be sure to attach the original Operation & Maintenance Manual to the forklift truck. In some countries, strict regulations do not allow imported forklift trucks for resale.
   For resale information, contact your authorized dealer.

#### LOCKOUT/TAGOUT

LOCKOUT is not only used to disconnect a power supply, but also to physically isolate power sources from supplying power to the forklift truck, with a lockout device, disabling the forklift truck.

TAGOUT also reduces the risk of operating the machine during LOCKOUT with the use of a "DO NOT OPERATE" or similar warning tag. Warning tags are ideally placed on the lockout device to indicate the forklift truck must not be operated until the tag is removed. Combined use of LOCKOUT/TAGOUT reduces the risk of accidental or inadvertent operation.

A forklift truck that has been LOCKED OUT and TAGGED OUT must not be operated until the required service has been completed and the forklift truck is no longer LOCKED OUT and TAGGED OUT.

NOTE: In the United States, employers have a responsibility to provide a safe workplace under the regulations of the Occupational Safety and Health Administration (OSHA). For more information on OSHA LOCKOUT/TAGOUT see the 29 CFR 1910.147 and Appendix A to 29 CFR 1910.147 (available at www.osha.gov).

#### **A WARNING**

- Personnel could be exposed to death or serious injury if LOCKOUT/TAGOUT procedure is not performed prior to servicing the forklift truck.
- Only the trained technician who performs the LOCKOUT/TAGOUT procedure must release the forklift truck back into service.

#### **A** WARNING

Basic requirements before servicing equipment:

- Wear appropriate personal protective equipment.
- Move equipment to secure maintenance area.
- Park the forklift truck on a hard and level surface with the forks lowered until the forktips touch the ground, parking brake applied, direction lever in the NEUTRAL position, engine stopped, and the wheels blocked.
- Turn the key switch to the OFF position.
- Remove the key from the key switch.

Typical LOCKOUT/TAGOUT procedures are shown below:

#### Battery forklift truck

- (1) Remove the key to the forklift truck from the key switch and access the battery compartment.
- (2) Disconnect the battery plug/connector and their connections from the forklift truck and place in the proper lockout device.
- (3) Lock the lockout device.
- (4) TAGOUT the forklift truck by placing a "DO NOT OPERATE" or similar warning tag where it can be visibly seen.
- (5) After the work is finished, the technician with the key to the forklift truck must unlock the lockout device and remove the tag.

### Chapter 1 Safety Rules for Forklift Truck Operators

### 1.1 GENERAL

The safety rules and regulations in this section are representative of some, but not all rules and regulations apply to forklift trucks. Rules are paraphrased without representation and have been reproduced verbatim.

Your forklift truck was manufactured in accordance with the National Fire Protection Association (NFPA) No. 505 and the American National Standards Institute, Inc. / Industrial Truck Standards Development Foundation (ANSI/ITSDF) B56.1, Safety Standard for Low and High Lift Trucks. Operate this forklift truck in accordance with local regulations.

See www.itsdf.org web site for more information on the B56.1 Safety Standards for Low Lift and High Lift Trucks.

The most effective way of reducing the risk of serious injuries, or even death, to you and others, is for you to know how to operate the forklift truck properly. Drive alertly and avoid maneuvers or conditions that could cause accidents.

As the operator, you are responsible for the safe operation of this forklift truck.

Be professional.

DO NOT operate a forklift truck if it is in need of maintenance, repair or appears to be unsafe in any way. Report all unsafe conditions immediately to your supervisor, then contact your authorized forklift truck dealer.

DO NOT attempt any adjustments or repairs unless you are trained and authorized to do so.

Continuing improvement and advancement of product design may have caused changes to your forklift truck, which are not included in this publication. Whenever a question arises regarding your forklift truck, or this publication, please contact your authorized forklift truck dealer for the latest available information

All forklift truck users should be familiar with their Local, Regional, and National regulations. United States users should be familiar with the Occupational Safety and Health Administration (OSHA), and ANSI/ITSDF B56.1, Safety Standard for Low and High Lift Trucks.

### 1.2 OPERATING ENVIRONMENT

### **A** WARNING

### Warehouse Rack Configuration

This forklift truck model needs to be carefully evaluated for use in warehouse environments where the rack design introduces potential hazards associated with horizontal rack-beam (crossbar) underride.

Horizontal rack-beam underride and potential rack-beam intrusion into the operator's compartment of a stand-up end control forklift truck traveling in tight confines in the "reverse," or "forks-trailing," direction is a recognized potential hazard, due to the rack system design in certain warehouses. Specifically, the potential for rack underride is created by a horizontal rack-beam positioned at a height that the beam can "fit" between the top of the unit's chassis/frame and the bottom of its overhead guard, and there are no corresponding ground level racks or guard rails

On July 27, 2009, the U.S. Department of Labor's Occupational Safety and Health Administration ("OSHA") published an important Safety and Health Information Bulletin ("SHIB") specifically addressing this potential hazard. This bulletin, entitled "Standup Forklift Under-Ride Hazards" (the "SHIB"), is available for review at https://www.osha.gov/dts/shib/shib072709.pdf.

Always look in the direction of travel and have a clear view of the area ahead. Never drive into another object.

If you see horizontal rack-beams that could introduce a potential rack-beam intrusion, **immediately** notify your employer and provide them with the above OSHA SHIB information



### 1.4 DESCRIPTION OF DANGER, WARNING, AND CAUTION DECALS

### 1.4.1 LOAD FORKS AND MAST WARNING DECAL

- Do not handle unstable or loosely stacked loads. Use special care when handling long, high or wide loads to avoid losing the load, striking bystanders, or tipping the forklift truck.
- Protruding racks or other objects can enter the operator area trapping or crushing you, resulting in serious injury to you or others. Know you work zone, be alert for changed conditions
- Do not overload forklift truck. Check capacity plate for load weight and load center information.
- Start, stop, travel, steer and brake smoothly. Slow down for turns and on uneven or slippery surfaces that could cause forklift truck to slide or overturn. Use special care when traveling without load as the risk of overturn is greater.
- Elevate forks or other lifting mechanism only to pick up to stack a load. Lift and lower with mast vertical or tilted slightly back—NEVER FORWARD. Watch out for obstructions, especially overhead.
- Operate tilting mechanism slowly and smoothly. Do not tilt forward when elevated except to pick up or deposit a load. When stacking, use only enough backward tilt to stabilize load.
- 12. Travel with load or lifting mechanism as low as possible and tilted back. Always look in direction of travel. Keep a clear view, and when load interferes with visibility travel with load or lifting mechanism trailing (except when climbing ramps).
- Use special care when operating on ramps—travel slowly, and do not angle or turn. When forklift truck is loaded, travel with load uphill.
   When forklift truck is empty, travel with lifting mechanism downhill.



- Observe applicable traffic regulations. Yield right of way to pedestrians. Slow down and sound horn at cross aisles and wherever vision is obstructed.
- When using forks, space forks as far as part as load will permit.
   Before lifting, be sure load is centered and forks are completely under load.
- Do not allow anyone to stand or pass under load or lifting mechanisms.
- 17. Do not lift personnel except on a securely attached specially designed work platform. Use extreme care when lifting personnel. Place forklift truck controls in neutral and apply brakes. Lift and lower smoothly. Be available to operate controls as long as personnel are on the work platform. Never transport personnel on forks or work platform.
- Before getting off forklift truck, neutralize control, fully lower lifting mechanism and set parking brake. When leaving forklift truck unattended, also shut off power.
- 19. Stay inside compartment until forklift truck comes to a complete halt.
- 20. Be aware of steering direction inherent to specific chassis.
- 21. Extend forks/attachments only to pick up or discharge loads.

Always stay healthy on the job. Forklift truck operators must be qualified as to visual, auditory, physical, and mental ability to operate the forklift truck safely.

**NEVER** operate the forklift truck under the influence of drugs or alcohol that may impair your ability to properly operate the forklift truck.



### Stay clear of pinch points!

Keep all parts of your body away from moving parts such as the mast, carriage and attachments. DO NOT place any part of your body between the overhead guard and the mast. If the mast moves unexpectedly, you could get caught between the mast and overhead guard and a serious accident could occur.




### 2.1 CONTROLS AND INDICATORS

The operator compartment utilizes controls that permit side stance and a standard open rear design. Side stance permits the operator to turn around and face the direction of travel whether traveling forward or reverse. The compartment also allows the operator to shift body weight and position to maintain maximum comfort. The open rear design minimizes operator fatigue by making it easy to get on and off the forklift truck. It also allows for the quickest exit from the forklift truck—an important safety feature should the forklift truck begin to tip or fall from an elevated height, such as a loading dock or ramp.

Location and function of the controls in the operator compartment are shown on the following pages.

# 2.3 FUNCTIONALITY OF OPERATOR PRESENCE SYSTEM

# 2.3.1 PREVENTING OPERATOR'S ABSENCE

Be sure to operate the forklift truck and system correctly. Also, be sure to properly maintain, as well as operate, the system at all times.

This function prevents the forklift truck from traveling or lifting without the operator pressing the operator presence pedal and traction pedal. For details, see the tables below.

#### 2.3.2 MAST OPERATION

When the operator raises their foot from the operator presence pedal, the mast will not lift, lower, or tilt even if the multi-function control handle is operated. To activate the mast functions, press the operator presence pedal.

#### 2.3.3 TRAVEL OPERATION

When the operator raises their foot from the traction pedal, the system cuts power to the traction motors.

To activate the traction motors and start traveling, press the operator presence pedal and the traction pedal simultaneously.

#### **A** WARNING

# 2.4 CONTROLLED ROLL BACK FUNCTION

This function prevents hazardous descending of the forklift truck on a grade. The controlled roll back is activated when the multi-function control handle is shifted into the neutral position or the traction pedal is slightly released on a grade. The descending speed changes with the steepness of grade and the weight of the load.

NOTE: This function is activated only in the output torque range of the traction motor. If the forklift truck can be decelerated until it stops in the output torque range, the electromagnetic brake will also be activated when the forklift truck stops.



Forklift truck descends slowly when traction lever is shifted into neutral position or traction pedal is slightly released on a grade.

#### 2.5 BATTERY DISCONNECT

#### **A** DANGER

This forklift truck contains high voltage. Disconnect the battery before servicing.




If forklift truck is to be left unattended for an extended period of time, such as overnight, disconnect battery. NEVER service a forklift truck while battery is connected.

#### 2.6 FORK PINS

#### A WARNING

When adjusting the fork spread, be careful not to pinch your hand between forks and lift bracket.



For load stability, adjust the forks as wide as possible.

To adjust the fork spread pull up and turn the pins to a 90-degree angle. Spread the forks to fit the load.

#### **A** CAUTION

After adjusting the fork spread, restore the pins to the original position to lock the forks. Position each fork the same distance from the center of the backrest.

# 2.7 REPLACING THE FORKS ON A FORKLIFT TRUCK


Remove a fork from the lift bracket to replace it or to access other parts of the forklift truck for maintenance

#### **A** WARNING

DO NOT try to install or remove a fork without a lifting device. Each fork could weigh in excess of 45 kg (100 lb.).

#### How to remove forks

- Slide the forks, one at a time, to the installation/removal recess on the bottom center of lift bracket bar.
- (2) Tilt the lift bracket FORWARD, then lower it until the fork hook disengages the forks from the lift bracket.

#### How to install forks

- Position the forks side-by-side on the floor in a location where they can be approached from the rear by the forklift truck.
- (2) Slowly drive the forklift truck, with the lift bracket fully lowered and fully tilted FORWARD, to a point just to the rear of the forks.
- (3) Carefully slide the forks, one at a time, onto the lift bracket so the top hook of the fork is placed above the top carriage bar.
- (4) Raise the lift bracket to engage the top hooks allowing the bottom hooks to pass through the installation/ removal recess.
- (5) Carefully slide each fork on the carriage bar so both the upper and lower hooks engage the lift bracket.
- (6) Lock the forks in place by engaging the fork lock pins.

#### Chapter 3 How to Avoid a Tipover / How to Survive One


# 3.1 KNOW WHAT FORKLIFT TRUCK STABILITY IS

#### 3.1.1.1 PRINCIPLE OF BALANCE

Forklift truck design is based on the balance of two weights on opposites side of a fulcrum. In the case of the forklift truck, the balance point is the drive tires of the vehicle. Because the forklift truck and its weight are fixed, when you increase the load distance from the balance point or increase the weight of the load, you will decrease the capacity rating of the vehicle. The load on the forks must be balanced by the weight of the forklift truck and the battery. The location of center of gravity of both the forklift truck and the load is also a factor. This basic principle is used for picking up a load. The ability of the forklift truck to handle a load is discussed in terms of center of gravity and both forward and sideways stability.

#### 3.1.1.2 CENTER OF GRAVITY

Center of Gravity (CG) is defined as the point of an object where its weight is evenly distributed. If the object is uniform, its geometric center will be the same as its CG. If it is not uniform, the CG could be a point on either side of the geometric center. When the forklift truck picks up a load, the forklift truck and load have a new, combined CG.



#### 1. CENTER OF GRAVITY

#### 3.1.1.3 STABILITY AND CENTER OF GRAVITY

The stability of the forklift truck is determined by the location of its CG, or if the forklift truck is loaded, the combined CG. The forklift truck has moving parts and, therefore, has a CG that moves. The CG moves up and down as the mast moves up and

down. The CG and, therefore, the stability of the loaded forklift truck, is affected by several factors such as:

- the size, weight, shape and position of the load
- · the height to which the load is lifted
- dynamic forces created when the forklift truck is accelerated, braked, or turned
- condition and grade of surfaces on which the forklift truck is operated.

#### 3.1.1.4 FORKLIFT TRUCK STABILITY BASE


Stability is a measure of the forklift truck's resistance to overturning. For the forklift truck to be stable, the CG must stay within the area of the forklift truck stability base—a triangular area between the drive tires and the steer tires. If the CG moves outside of the line on either side of the stability base, the forklift truck will tip to the side. When lift height is added a stability pyramid is formed—a triangular area between the top of the mast, down to the drive tires and steer tires.

# 3.1.1.5 CAPACITY (WEIGHT AND LOAD CENTER)

The capacity of the forklift truck is shown on the capacity plate. It is determined by the weight and load center. The load center is determined by the location of the CG of the load.

The load center shown on the capacity plate is the horizontal distance from the front face of the forks, or the load face of an attachment, to the CG in the load. The location of the CG of the vertical direction is the same as the horizontal dimension.


#### CHAPTER 3 HOW TO AVOID A TIPOVER / HOW TO SURVIVE ONE



Keep in mind that, unless otherwise indicated, the capacity shown on the capacity plate is for a standard forklift truck with standard lift bracket, tires authorized by the manufacturer, forks and mast, and having no special-purpose attachment. In addition, the capacity presumes the load center is no further from the top of the forks than it is from the face of the lift bracket.

If these conditions do not exist, the operator may have to reduce the safe operating load because the forklift truck stability may be reduced. The forklift truck should not be operated if its capacity plate does not indicate capacity.

#### 3.1.1.6 CAPACITY NAME PLATE



The capacity name plate shown is for a 1.5 ton model forklift truck whose capacity is 794 Kg (1,750 lb.) with a 4785 mm (188 in.) mast installed. The chart specifies this forklift truck can lift up to 794 Kg (1,750 lb.) if the load center is not more than 600 mm (24 in.) forward from the face of the backrest and 600 mm (24 in.) measured vertically from the top of the forks. Before attempting to pick up a load, make sure that its weight is within the capacity of the forklift truck at the load center involved. The capacity is also affected by the

weight of the battery. The battery must be within the minimum and maximum weights.

**NOTE:** Capacity name plate will differ depending on the model and options.

NOTE: If the load is not uniform, the heaviest portion should be placed closer to the lift bracket and centered on the forks.

#### 3.1.1.7 ATTACHMENTS

#### **A** WARNING

Make sure the capacity name plate is correct if an attachment has been installed.

If an attachment is installed on the forklift truck, make sure the attachment operating instructions are available and understood before operating the attachment.

#### A DANGER

In the event of an imminent tip-over step off and away from the forklift truck as quickly as possible.

Exit from a stand-up type forklift truck with rear entry access by stepping backward if a tipover occurs.

#### **A** CAUTION

- Capacity name plates originally affixed to forklift trucks sold by the manufacturer shall not be removed, altered or replaced without prior written approval from MCFA.
- The manufacturer assumes no responsibility for forklift trucks placed in service without a valid manufacturer capacity name plate.
- If it is necessary to change your specifications, contact your dealer.

#### **A** WARNING


When the forklift truck is equipped with a high mast, the capacity is reduced based on lift heights. Before attempting to lift any load, make sure the weight and load center combination is within the capacity of the high mast as shown on its capacity name plate.

When the forklift truck is equipped with any special-purpose attachment, the capacity is varied by the weight of the attachment and the front overhang (horizontal distance from the center of the front axle to the vertical faces of the forks). Before attempting to lift any load, make sure the weight and load center combination is within the capacity of the attachment as shown on its capacity name plate.

# 3.2 DO'S AND DON'T'S TO AVOID TIP OVER

#### **A WARNING**

- In case of tip over, jump clear of the forklift truck.
- Exit from a forklift truck with rear entry access by stepping backward.



# Be aware of the stability of an empty forklifttruck!

An empty forklift truck could tip over more easily than a loaded one.

In the event of an imminent tip over step off and away from the forklift truck as quickly as possible.

#### **A** WARNING



#### DO NOT turn on a ramp or grade!

Turning on a ramp or grade could cause a forklift truck, loaded or unloaded, to tip over.

#### **Chapter 4 Operation**

#### 4.1 NEW FORKLIFT TRUCK BREAK-IN

Correct break-in is important for operation and long life of the forklift truck. Read these recommended procedures:

#### **A** CAUTION

- If the forklift truck cannot be put to work immediately, or the operation is light and slow, break in the forklift truck under a simulated working condition.
- Change oils and relubricate at shorter intervals than the normal recommended intervals when in dirty environments.
- Hydraulic tank return line filter should be replaced after the first fifty (50) hours of operation and at the recommended intervals thereafter.
- Carefully check on and around the forklift truck for loose bolts and nuts. Retighten them.

# 4.3 BEFORE MOVING THE FORKLIFT TRUCK

# 4.3.1 BEFORE MOVING THE FORKLIFT TRUCK - OVERVIEW

Before operating your forklift truck, make sure you read and understand all warnings, including the following:

#### **A** WARNING

- Operate this forklift truck slowly and in an open area until you are thoroughly familiar with all the controls.
- Operate this forklift truck only from the designated operating position. Never place any part of your body between the mast upright or outside the operator compartment while operating this forklift truck. (The operator compartment is that space in which the operator stands to operate the forklift truck.)
- Avoid sudden stops or changes in direction which could cause the vehicle to tip or the load to shift.

#### 4.3.2 START-UP PROCEDURE

- Make sure battery is charged.
- 2. Make sure both battery gates are in place
- Make sure battery cannot move more than ½ inch (13mm) in any horizontal direction.
- 4. Connect battery to forklift truck.

**NOTE:** Battery cable should not be routed outside the profile of the truck.

- Turn the key switch clockwise to the ON position or enter the code in the key pad (optional). Start PIN 2580. SelfTest will start and readings will be shown on the display. Do not activate any control elements, such as the operator presence pedal during SelfTest.
- After the SelfTest is complete, step into the operator compartment. Depress the operator presence pedal with right foot and the traction pedal with left foot.

#### **CHAPTER 4 OPERATION**

SelfTest can be identified by the contactor clicking. If faults are found during a SelfTest, a fault message is shown on the operator display. An alarm is indicated on the operator display. Do not operate the forklift truck until the problem is corrected.

- 7. Make sure forks are lowered completely.
- Check the operation of the EPO button as follows:
  - a. Pull the EPO button OUT while twisting it clockwise.
  - b. Turn the key switch clockwise to ON.
  - c. Push the EPO button IN. This should completely shut down the forklift truck. You should not be able to drive the forklift truck, lift the forks, tilt the carriage, etc.
  - d. Turn the EPO button clockwise and pull up to release.
- Release parking brake by pressing the button directly below the parking brake icon on the console display screen.
- Use your left hand to steer the forklift truck and your right hand to control travel, lift and auxiliary functions. See <u>Forklift Truck</u> <u>Operation</u>, <u>Page 4-3</u>
- 11. Test the steering.
- 12. Test the brakes.
- 13. Test the parking brake.
- 14. Test the horn button.
- 15. Check the operator presence pedal for functionality.
- 16. Test the drive function.
- 17. Check the lift function.

The forklift truck is operational.

NOTE: The forklift truck can be driven either forks first or tractor first. If you are not sure which way the forklift truck will move, slowly move the multi-function control handle forward or reverse to determine which way the forklift truck is moving.

# 4.4 ADJUSTABLE COMFORT OPERATOR PLATFORM

The Comfort operator platform has adjustable springs to increase comfort when driving on uneven surfaces. The human vibrations that affect the operator during travel are significantly reduced with a suitable setting. Above the operator platform, up to six gas pressure springs can be switched with a lever to adjust to the operator's weight (79).


**NOTE:** The gas pressure springs 5 and 6 have double the pressure force.








1 ROCKER SWITCH

#### 4.6 FORKLIFT TRUCK OPERATION



A forklift truck is different from most other vehicles in that it is steered by the rear wheel. This causes an exaggerated tail swing. Drive slowly when making turns in close quarters. Start the turn as close to the inside corner as the tail swing will permit.




Turning with the forks elevated, with or without a load, could cause a tipover.

In the event of an imminent tip-over step off and away from the forklift truck as quickly as possible.



Be aware of tail swing distance. Be sure the tail swing area is clear, before turning, to avoid injury to pedestrians.



Use extreme care when turning without a load. Excessive speed with abrupt turns or uneven surfaces may cause the forklift truck to tip when empty as well as loaded.

#### **CHAPTER 4 OPERATION**

In the event of an imminent tip-over step off and away from the forklift truck as quickly as possible.

#### 4.7 CHANGING SPEED


The forklift truck will change its speed to match the position of the multi-function control handle. The farther the multi-function control handle is moved from the neutral position, the faster the forklift truck travels. This is true when accelerating and

decelerating. This means the forklift truck is not free to "coast" long distances when the travel control is returned to the neutral position.

#### 4.8 TRAVEL DIRECTION

#### 4.8.1 TRAVEL DIRECTION DEFINITION

The following specifications are given for defining the travel direction:

#### 4.8.2 PARKING BRAKE WARNING ICON

#### 4.9 CHANGING DIRECTIONS

- Move the multi-function control handle through neutral to the direction opposite of your current travel. This action is called "plugging." The farther you move the multifunction control handle, the faster you slow down
- The forklift truck slows, stops, and starts moving in the opposite direction. Plugging is the recommended method of slowing travel speed and changing direction during operational maneuvers.

#### 4.10 BRAKING

The forklift truck's braking response depends largely on the travel surface conditions. The operator should adapt his or her driving style accordingly.

The forklift truck can be stopped in three ways:

- With the traction pedal
- With the coasting brake (multi-function control handle)
- With the reverse brake (multi-function control handle)

#### **A WARNING**

# Risk of accidents due to individually set parameters

If the forklift truck is driven by several operators (for example in multi-shift operation), be aware of modified braking and driving response due to individually set parameters!

**NOTE:** Check the response of the forklift truck when starting up.

#### **A** WARNING

#### Risk of accidents

The braking response of the forklift truck depends largely on the travel route conditions.

NOTE: The operator must be aware of travel route conditions and take them into account when braking.


Brake the forklift truck with care to prevent the load from slipping.

When driving with a load, allow for longer braking distances.

In case of danger, brake only with the service brake.



# 4.10.1.1 BRAKING WITH THE SERVICE BRAKE




- 1. Take foot slightly off the traction pedal (13).
  - The forklift truck decelerates slightly.
- 2. Lift foot off the traction pedal (13). The forklift truck decelerates.

# 4.10.1.2 BRAKING WITH THE COASTING BRAKE



 Release the multi-function control handle to the neutral position (83).
 The forklift truck decelerates.

# 4.10.1.3 BRAKING WITH THE REVERSE BRAKE



 While traveling, switch the multi-function control handle (83) to the opposite travel direction.

The forklift truck decelerates until it starts to move in the opposite travel direction.

#### 4.11 PLUGGING

Plugging is the correct method for stopping the forklift truck. Plugging provides the means to bring the forklift truck to a smooth, controlled stop.

 Move the multi-function control handle through the neutral position in the direction opposite direction the forklift truck is traveling.  The forklift truck will slow down, come to a stop, and then start traveling in the opposite direction. The farther past neutral you move the multi-function control handle, the greater the plugging force.

The brake which is engaged when lifting your foot off the operator presence pedal or traction pedal should only be used in emergency situations.

#### 4.12 AT THE END OF EACH SHIFT

- 1. Park the forklift truck in a secure and authorized parking area.
- 2. Stop the forklift truck.
- 3. Lower the forks completely.
- 4. Turn the key switch OFF (O).

- 5. Push in the EPO (Emergency Power Off) button
- 6. Remove the key from the key switch.
- 7. Disconnect the battery.
- 8. Check around forklift truck for leaking hydraulic fluid.

#### **A** WARNING

Never park this forklift truck on a ramp or a slope.


DO NOT park this forklift truck in a cold storage area overnight.

#### **Chapter 5 Operating Techniques**

#### 5.1 STACKING METHODS


# 5.1.1 STACKING LOADS DIFFERING IN SIZE

Be sure larger containers in a load are at the bottom of the stack and smaller ones at the top; or heavier containers at the bottom and lighter ones at the top.




# 5.1.2 STACKING SMALL IDENTICAL LOADS

As in brick laying, place layers of containers alternately so each container will stand astride parts of two or more containers in the layer below. This type of stack is more stable and less likely to fall down.




# 5.1.3 STACKING LARGE IDENTICAL LOADS

Below is one of the most common patterns for stacking large identical containers. Better load stability is achieved by reversing the end-to-side direction on each succeeding layer.



#### 5.2 LIFTING THE LOAD

- Move up to the load and stop the forklift truck 20 to 30 cm (8 to 12 in.) short of the load.
- (2) Make sure the forklift truck is square with the load and the forks are at the correct height.



1. 20 TO 30 CM (8 TO 12 IN.)


#### **A** WARNING

When you pick up loads that extend above the lift bracket extension height, band them together to reduce the risk of items from falling.




(3) Tilt the mast FORWARD to the VERTICAL position, and make sure the forks are at the correct height.




#### **A** WARNING

Only stable or safely arranged loads must be handled. DO NOT pick up an off-center load. Make sure the weight of the load is centered between the forks.




- (4) Push the multi-function control handle toward the forks to the FORWARD position and slowly move the forklift truck FORWARD.
- (5) Slide the forks into the pallet until they are fully under the load.




#### **A** WARNING

Avoid approaching the load at high speeds. Under all travel conditions, operate the forklift truck at a speed that will permit it to be brought to a stop in a safe manner.



(6) Carefully lift the load about 10 cm (4 in.) off the stack. Slowly return the lift lever to the NEUTRAL position.



# DO NOT mistake the direction and control levers!

If you operate the steering wheel or multi-function control handle incorrectly, collision of the forklift truck with persons or objects could occur, or you could drop the load.

#### 5.3 TRAVELING WITH THE LOAD

# WARNING 11\_3B

- NEVER travel with the lift bracket tilted forward or with the load in the elevated position. This could increase the possibility of the forklift truck tipping over.
- NEVER leave the forklift truck with the load in the elevated position.

- Make sure the load is centered on the forks. Then tilt the carriage all the way back.
- Before moving the load, look around for pedestrians, other vehicles, and obstacles.
- Slowly move the forklift truck 20 to 30 cm (8 to 12 in.) away from the stack, then stop the forklift truck. Lower the load to a position 15 to 20 cm (6 to 8 in.) above the ground.
- 4. Look around to make sure your drive area is clear


# A WARNING

Slack lift chains mean there is a rail or lift bracket hang-up. Raise the mast before you move.

When stacking:

- 1. Watch your lift chains.
- 2. If they go slack, stop, raise the load and lower it again.

#### **CHAPTER 5 OPERATING TECHNIQUES**



Only stable or safely arranged loads must be handled!

Keep the center of gravity low and avoid offcenter loading. Off-center loads could cause tipover or falling loads.


Slowly operate the forklift truck when picking up or placing a long or wide load, or when turning with such a load.

In the event of an imminent tip-over step off and away from the forklift truck as quickly as possible.



If the load blocks your view, or when you travel down a grade with the load, drive in reverse. Always look in the direction of travel.


#### 5.4 UNLOADING




 Move the forklift truck slowly and stop 20 to 30 cm (8 to 12 in.) short of the rack or load. Make sure the forklift truck is square with the rack and load.




 Raise the load with enough height to clear the loading platform and be careful not to hit upper rack level. Level out the load with the tilt button on the multi-function control handle.




Once you are clear, you may need to move the forklift truck forward to even up the load or reposition the load.



4. Watch your drive tires and do not hit the rack.



 Carefully lower the load onto the rack platform.
 Be careful not to drag the forks.



 Look behind and around the forklift truck and to see that it is safe to carefully back the forklift truck away from the rack. Proceed to your next load.

#### 5.5 WORKING ON GRADES



- NEVER elevate the mast when the forklift truck is on a ramp
- NEVER elevate a load with the forks tilted down
- NEVER travel with the load elevated when the forklift truck is on a ramp.
- NEVER turn on a ramp.
- · NEVER travel across a grade
- Always make sure the forklift truck is square with the ramp before ascending or descending.

#### Chapter 6 Storing the Forklift Truck

#### 6.1 END OF SHIFT STORAGE

#### **A WARNING**

Perform a thorough walk-around inspection for any damage. Report all damage or faulty operation immediately. DO NOT operate a forklift truck that has a maintenance problem.

- Park the forklift truck in an authorized area
- 2 Check under the forklift truck for oil leaks
- Clean the forklift truck to keep it free of dirt and oil.

This will make it easier to spot loose or defective parts.

#### **A** CAUTION

Do not expose controller units to water. Take care not to sprinkle water over controller units when washing your machine.

#### **A** WARNING

- NEVER splash water over the forklift truck.
- Use pressurized air or a vacuum cleaner to clean the forklift truck

#### 6.2 LONG-TERM STORAGE

If your forklift truck is to be put in storage for any length of time, take the following precautions for safety and to reduce the risk of deterioration of forklift truck components.

#### 6.2.1.1 HYDRAULIC SYSTEM

After positioning your forklift truck for storage, retract all the hydraulic cylinders to minimize rod exposure. This will reduce the risk of rusting of the sliding contact surfaces of the rods.

#### 6.2.1.2 BATTERY

- Fully charge the battery. Recharge it with an equalizing charge if the forklift truck is left standing for more than three days.
- Charge the battery with an equalizing charge at least once a month if the forklift truck is to be left standing for more than a month.


#### **Chapter 7 Transportation Hints**

#### 7.1 FORKLIFT TRUCK SHIPPING

- Always block the trailer or rail cars wheels before loading the forklift truck.
- Position the forklift truck on the truck bed or rail car.
- 3. Fully lower forks or attachment to the floor.
- 4. Place the multi-function control handle in the neutral position
- 5. Turn the key switch to the OFF position and remove the key.
- Block the wheels and block in the truck to secure the forklift truck.

#### A CAUTION

DO NOT turn steering wheel after the forklift truck has been secured. It may loosen the tie-downs.



#### **A** WARNING

Check travel route for overpass clearances. Make sure there is adequate clearance if the forklift truck being transported is equipped with a high mast or cab.

Remove ice, snow, or other slippery material from the shipping forklift truck and loading dock.

# 7.2 FORKLIFT TRUCK LIFTING AND TIEDOWN INFORMATION

Take the following safety precautions when lifting or tying down forklift trucks.

- Use proper rated cables and slings for lifting. Position the crane so the forklift truck is level when lifted.
- Spreader bar widths should be sufficient to prevent contact with the forklift truck.
- Use the tie-down locations provided for forklift truck tiedown.

#### **A** CAUTION

Incorrect lifting or tie-downs could cause a load to shift and could cause injury and/or damage.


NOTE: Check the state and local laws governing weight, width, and length of a load. Contact your authorized dealer for shipping instructions for your forklift truck.

#### **Chapter 8 Special Situations**

#### 8.1 CARE IN COLD WEATHER

#### 8.1.1 BATTERY

- Maintain the specific gravity of electrolyte above 1.260 as corrected to 27°C (80°F).
- When you park your forklift truck overnight, leaving it outside a garage, remove the battery and keep it warm.
- The electrolyte of a fully charged battery will not freeze to -35°C (-31°F).
- Do not leave the forklift truck in a freezer overnight.



#### **A** CAUTION

- After distilled water has been added to the battery, drive the forklift truck. This mixes the added water with the electrolyte and will reduce the risk of freezing and damaging the battery.
- DO NOT attempt to restore a battery's charge by pouring boiling water over it.
   This can break the battery case, resulting in acid contact with skin or eyes.

#### 8.2 CARE IN HOT WEATHER

#### 8.2.1 HOT WEATHER BATTERY SERVICE

In hot dry weather, check the battery cells for proper electrolyte level more often than in cold weather. Add distilled water whenever the level is low.

 Use hydraulic and gear oil suitable for the ambient temperatures.

- For selection of hydraulic oil and gear oil, consult your Service Data chart for recommended oils or your authorized dealer
- In addition, a lubrication chart is located inside the operator compartment door at the rear of the forklift truck.

#### 8.3 COLD STORAGE SPECIFICATIONS

# 8.3.1 DESCRIPTION OF THE ENVIRONMENT AND OPERATION OF THE FORKLIFT TRUCKS

Cold storage conditioning is required when a forklift truck operates in cold storages such as coolers or freezers. Condensation, especially when frozen, is a primary issue in this environment. Cold storage conditioning is also recommended when a forklift truck operates in a high humidity environment.

Cold storage applications are divided into two groups:

# **<u>COOLER</u>** (High Temperature Freezer Forklift Truck)

Applies to forklift trucks operating in:

- Environments where ambient temperatures fluctuate from +20°F (-7°C) to +70°F (21°C).
- Continuous duty cycle in cooler or high temperature freezer.
- Applications where forklift trucks go in and out of freezers for short periods of time. A short period of time is defined as 5 minutes.
- · Very wet environments

# <u>FREEZER</u> (Low Temperature Freezer Forklift Truck)

Applies to forklift trucks operating in:

- An environment where temperatures fluctuate from +40°F (4°C) to -40°F (-40°C). This would be where the forklift truck operates between a cooler and low temperature freezer.
- A continuous temperature of -20°F (-29°C) for an entire shift

#### **CHAPTER 8 SPECIAL SITUATIONS**

The most extreme usage of the forklift truck includes frequent driving between low temperature freezer and warm warehouse areas with high humidity. In such usage, heavy condensation, formation of ice and corrosion can occur. It is preferable that when low temperature freezer forklift trucks are not used, they are kept in an area where the temperature is between 30°F (-1°C) and 23°F (-5°C) and the humidity is low.


Cold storage applications require well-trained forklift truck drivers and regular forklift truck maintenance.

#### COLD STORAGE MODIFICATIONS

When preparing the forklift truck for cold storage conditioning, the number of modifications should be kept to a minimum.

- Water drainage is already considered in the standard chassis design.
- Some preconditioning and painting of the components will be used.
- All hinges, axles, and bearings are surface treated or equipped with grease fittings.
- Replacement of the hydraulic oil is not required in Cooler (High Temperature Freezer Truck) in some cold storage applications.

# 8.4 CARE IN SEVERE DUST OR LINT CONDITIONS



For operating the forklift truck in severe dust or lint conditions, consult your dealer.

#### **Chapter 9 Maintenance**

#### 9.1 GENERAL



Taking proper care of your forklift truck is a vital part of the overall planned maintenance program.

Your participation in this program will provide an early warning to help identify potential maintenance problems.

Do-it-yourself maintenance does not include repairs. If your forklift truck requires any repairs, contact your authorized dealer. The mechanics of Mitsubishi forklift truck dealers are well trained and know how to safely make repairs.

#### A WARNING

- Make sure the service area is safe
- Follow the recommended safe procedures.
- Use only the right tools for the job.
- Park the forklift truck on a level surface with the forks lowered, multi-function control handle in NEUTRAL and battery disconnected
- All repairs must be made by authorized personnel.

Follow these rules to save yourself and others from injury and to service your forklifttruck properly.

#### A WARNING

Should the forklift truck become unsafe during operation in any way whatsoever, you must report it immediately to the designated authority. The forklift truck must not be used again until it has been restored to safe operational condition.

#### **A** WARNING

#### Lines, Tubes, and Hoses

- Leaks could cause fires. Contact your authorized dealer for repair or replacement.
- DO NOT bend or strike high pressure lines. Check lines, tubes, and hoses carefully.
- DO NOT install bent or damaged lines, tubes, or hoses.
- Repair loose or damaged oil lines, tubes, or hoses.
- DO NOT use your bare hands to check for leaks, use a board or cardboard.
- Tighten connections to the recommended torque.
- Make sure all clamps, guards, and heat shields are installed correctly to reduce the risk of vibration, rubbing against other parts, and excessive heat during operation.

# If any of the following is found on a part, replace the part.

- End fittings damaged or leaking
- Outer covering chafed or cut and wire reinforcing exposed
- Outer covering ballooning locally
- Evidence of kinked or crushed hose
- Metal embedded in the outer cover
- End fittings displaced

#### **A WARNING**

#### BE SURE to perform inspections.

- If you fail to perform required inspections, it could lead to accidents.
- Operate the forklift truck at a reduced speed during inspections. An accident could be caused if operated at normal speed and the forklift truck is faulty.
- Dress properly for the job. DO NOT wear loose clothing or accessories such as flapping cuffs, dangling chains, neckties, scarves, or rings that could catch in moving parts.
- Wear personal protective equipment appropriate for the conditions of your work places.

#### 9.2 INSPECTION PRECAUTIONS

You must read and understand the warnings and instructions contained in this manual before performing maintenance procedures.

#### **A** WARNING


Turn the key switch to OFF and disconnect the battery before lubricating or performing any maintenance on the forklift truck (unless instructed otherwise in this manual or in the Service Manual).

The recommended maintenance intervals are for the forklift truck operating under normal conditions. If operation is in adverse conditions or corrosive environments, inspect the forklift truck more frequently.

#### **A** WARNING

If it is necessary to make an inspection while the forklift truck is turned on, ALWAYS USE TWO WORKERS— one, the operator, at the controls and the other checking where the operator can see him.

#### **A** WARNING



If your forklift truck requires any repair, attach a "DO NOT OPERATE" or similar warning tag to the steering wheel or multi-function control handle, remove the key, and contact your dealer.

#### **A** CAUTION

Changing the drive tires and steer tire on your forklift truck is a specialized task. If the tire or wheels need replacement contact your dealer.

#### **A** CAUTION

- Avoid mixing lubricants. In some cases, different brands of lubricants are not compatible with each other and deteriorate when mixed. It is best to stick with the same brand at successive service intervals
- Before refilling, clean filler holes. After filling, clean up spills.

#### **A** CAUTION

A daily (Pre-Start) inspection is the key to safety. At the beginning of each shift, check your forklift truck to make sure it is in a safe operating condition. Always inspect your forklift truck under the following conditions:

- Forklift truck on a hard and level surface
- Mast in vertical position
- Forktips on ground
- All motors stopped
- Parking brake applied
- Control levers (switches) in the NEUTRAL position
- Wheels blocked

#### A CAUTION

Contact your authorized dealer for the proper disposal of wastes accumulated after replacement of tires, batteries, oils, and fluids.

#### 9.3 MAINTENANCE SCHEDULE

# 9.3.1 MAINTENANCE SCHEDULE - OVERVIEW

As the operator, you are responsible for the performance of a pre-start inspection "Every 10 Service Hours or Daily." You are also responsible for those items listed under "Every 50 Service Hours or Weekly" (whichever comes first) in the Maintenance Intervals Chart to keep your forklift truck in proper working condition.



For periodic inspection and periodic change of parts, however, rely on the expert knowledge of the factory-trained servicemen, and the service facilities at your dealer's workshop.


#### Periodic Inspection Time Intervals

One month (30 days) or 200 service hours after delivery of a new forklift truck, (whichever comes first)

Every 1000 hours or 6 months (whichever comes first)


Every 2000 hours or 1 year (whichever comes first)

NOTE: Periodic inspection time intervals stated above are based on normal operating conditions. They must be reduced accordingly if the forklift truck is used in conditions of extreme dust, temperature, fluctuations, multiple shifts and so on. Contact your authorized dealer.



Your pre-start inspection duties (Every 10 Service Hours or Daily) are covered in the remainder of this section.

#### 9.3.2 PRE-START INSPECTION



Fill out a pre-start inspection sheet. Remember, a complete and thorough pre-start inspection is the best insurance against personal injury and property damage.

- Check the daily inspection list.

#### 1. Battery

- Was battery fully charged before start of shift?
- Was water level checked after charging?
- Check for leakage—look for battery acid on floor
- Is the battery weight within the range specified on the battery size label decal?
- Battery weight must meet minimum requirements listed on the forklift truck capacity plate.

# 2. Battery Connector and Emergency Power Off (EPO) Switch

- Battery cables and connector are in good condition.
- Battery connector makes a solid electrical connection between battery and the forklift
- EPO switch powers down forklift truck when you press the switch.

#### 3. Battery Gates

- Are battery gates properly installed and securely locked into place.

#### 4a. Operator Presence Pedal (Brakes)

- Does operator presence pedal operate smoothly with no binding?
- Does it stop the forklift truck within specific limits?
- Does it disable the travel function when pedal is released?

#### 4b. Traction Pedal

 Does traction pedal operate smoothly with no binding?

#### **CHAPTER 9 MAINTENANCE**

 Does it disable the travel function when pedal is released?

#### 7. Mast

- Check to ensure there is no damage to hoses and limit switches.
- Check inside channels for lubrication.
- Is there any indication of leaks from the cylinders or hydraulic lines?
- Does the mast move up and down smoothly when you operate the multifunction control handle?
- Does the mast tilt forward and backward smoothly when you operate the tilt function on the multi-function control handle?
- Is the load backrest extension properly secured to the mast?
- Inspect the load backrest extension for cracks and distortions. (Special attention should be given to all welds).
- Shake the backrest extension to check for excessive rattle.
- Are lift and lower stops installed and in good condition?

#### 8. Lift Chains

- Inspect lift chains for lubrication and visible damage.
- Are lift chains properly lubricated?
- Are lift chains adjusted to the correct length?
- Inspect chains for proper tension and position.
- Are lift chains equal in tension?
- Check by pushing the chains midway.
- If the chains are loose or the tension is not equal, have the chains adjusted.

#### 11 Forks

Are the fork stopper pins properly engaged?

# 12. Function Controls on multi-function control handle

 Does the multi-function control handle move smoothly, without binding?

- Does it move to neutral when it is released?
- Does the forklift truck go forward or backward when the multi-function control handle is moved toward its respective function?
- Does the mast lift and lower when you operate the lift and lower functions of the multi-function control handle?
- Does the mast tilt forward and backward when you operate the tilt function on the multi-function control handle?

#### 13. Horn

 Does the horn sound when you press the horn button?

#### 14. Hydraulic Connections

- Check all hydraulic connections to cylinders and hoses.
- Check floor around and under forklift truck for hydraulic oil leaks.

#### 15. Hydraulic Reservoir

- Check hydraulic fluid level.

#### 16. Lights (if equipped)

- Are the lights in safe working condition?
- Are the lenses clean and not defective?
- Do the lights come on illuminate when you switch them on?

#### 17. Switches

 Do the switches work for each of their assigned functions?

#### 18. Steer Wheel. Drive Tires

- Are the tires in good condition?
- There should be NO cracks, NO flat spots, NO missing chunks or No bond failure.
- Tires should have adequate tread.

#### 19. Static Strap (if equipped)

- Is the static strap attached?

#### 20. Overhead Guard

 Check the front and rear overhead guard mounting bolts on each side.

- Carefully inspect the overhead guard for cracks and distortion. (Special attention should be given to all welds).
- Contact your dealer if repairs are needed.

#### 21. Loose Components and Hardware

- All guards and covers installed and secure.
- Check for damage to components.
- Check all welded components. There should be no cracks.
- Check forklift truck for loose or missing hardware. (Tighten loose hardware).

#### 22. Decals and Warning Labels

 All Decals - (Warning/Safety/Operational) in place and legible.

#### 23. Fire Extinguisher (if equipped)

- Is the extinguisher charged and secured?

#### 24. Ventilation Slots

 Are the ventilation slots free of obstructions?

#### 26. Optional Warning Devices (if equipped)

- Do all optional warning devices operate properly? Optional Warning devices include such items as:
- Lights
- Backup Alarms
- Strobe Lamp

#### 27. Steering

 Check the steering angle indicator by turning the steering wheel in both directions until it stops and check that the wheel position is displayed on the control panel.

#### 28. Operator Compartment

- Make sure the operator compartment and the controls are clean for a safe operation.

# 9.5 EVERY 50 SERVICE HOURS OR WEEKLY, WHICHEVER COMES FIRST

#### 1. Battery

 Using a soft cloth, wipe away dirt and dust from the top and sides of the battery.


#### 9.10.2 CHECK THE HYDRAULIC OIL LEVEL

#### **A** WARNING

The hydraulic oil is under pressure during operation and is hazardous to health and the environment.

- Do not touch hydraulic lines under pressure.
- Dispose of used oil according to specifications and regulations. Store used oil safely until it is disposed of in accordance with regulations.
- · Avoid hydraulic oil spill.
- Remove spilled and/or escaped liquids immediately using a suitable binding agent.
- Dispose of the mixture of binding agent and consumables in compliance with applicable regulations.
- Legal requirements for handling hydraulic oil must be observed.
- · Wear safety gloves when handling hydraulic oil.
- Wear safety glasses when handling hydraulic oil.
- Do not allow hydraulic oil to touch hot motor parts.
- Do not smoke when handling hydraulic oil.
- Avoid contact and consumption. If swallowed do not induce vomiting. Instead find a physician immediately.
- If you inhale oil mist or vapors, let in fresh air.
- If oil comes in contact with the skin, wash off oil with soap and water.
- If oil comes in contact with the eyes, rinse them out with water and find a physician immediately.
- Change soaked clothes and shoes immediately.





#### 9.11.4 REMOVING THE BATTERY

When performing maintenance or changing the battery always remove one of the battery gates, usually the battery gate on the side where the battery connector is located.

Follow these steps when removing a battery from a forklift truck that has battery gates:

- Park the forklift truck on level ground, push the EPO button in and remove key.
- Make sure both battery gates are properly installed.
- Before removing the battery gate, usually the battery gate on the side where the battery connector is located make sure the opposite battery gate is locked in place.
- 4. Pull up on the battery gate handle and set the battery gate aside.
- 5. Disconnect the battery and then remove the battery.

- Using a battery stand or equivalent material handling equipment, slide the battery out of the open end of the battery compartment.
- Make sure the removed battery is properly stored.



Never operate the forklift truck without the correct size and weight of battery in the forklift truck.

#### **A** WARNING

Never use chain or other items for lifting a battery that is not specifically designed for the task.

When removing a battery from a forklift truck, always use a battery stand or equivalent material handling equipment.

If acid gets in your eyes, FLUSH THEM IMMEDIATELY WITH LARGE AMOUNTS OF WATER AND SEE A DOCTOR AT ONCE.

#### 9.11.5 INSTALLING THE BATTERY

#### A CAUTION

Crushing may result in damage to the battery cable.

Crushing may occur when inserting the battery if the battery cable is inserted without a cable guide.

- Always install the battery with a cable guide.
- Contact the manufacturer's service department when replacing the factoryfitted battery.

**NOTE:** A battery extraction device and Allen key will be need to perform this procedure.

NOTE: Installation is the reverse order. When reinstalling the battery, note the proper installation position and make sure the battery is connected correctly.

- Tighten the retaining screw (105) and lock nut (105) or handle on the battery lock (104).
- 2. Connect the battery to the forklift truck plug.
- 3. Install battery gate.

#### **A** WARNING

Take precautions not to jam or cut the battery cables during installation of the battery as this may result in a short that could cause a fire or battery explosion.

When installing a battery, always be sure that it is fully charged before placing the forklift truck into operation.

#### **A** WARNING



Always charge the battery in a well-ventilated area. DO NOT smoke, and keep any type of flame away from equipment. DO NOT use equipment in this area that is liable to produce sparks.



   This should be done every day and normally takes eight hours to fully charge a battery.
- Equalizing charge.
   This charges the battery at a slow rate and balances the charge in all the cells. This should normally be done once per week.
   The most accurate check of specific gravity is obtained after the equalizing charge is complete.

#### · Check the battery charge

- Use a hydrometer.
- Complete the pre-start inspection procedure.



Explosive gases are generated when batteries are being charged. Always ensure adequate ventilation for battery charging. Do not smoke, keep flames and sparks away.

#### **A** CAUTION


- Always turn off charger before connecting or disconnecting the battery.
- Always check the water level before charging to make sure the plates are covered.
- Never overfill before charging. The electrolyte will expand during charging and may overflow.
- After charging, add water to the battery manufacturer's full mark.
- Do not plug a battery charger into the forklift truck. This severely damages the forklift truck's electrical systems.






